Suicide Risk Assessment (SRA) Solution

Suicide prevention and risk assessments have been a top priority in K-12 schools and are even more crucial now due to the COVID-19 pandemic.

The effects of traumatic experiences can be manifested as suicidal ideation and may lead to incidents of threat to self, or self-harm, which are reported in schools. To help address this growing need, school districts need to:



Develop suicide prevention and assessment policies and procedures

Identify evidenced-based protocols for identifying and assessing students at risk

Implement processes for identifying, assessing, developing safety plans, and monitoring interventions and supports provided


